Royal Windsor Racing Club Terms & Conditions of membership

1. The racing club currently leases racehorses in training so that members can enjoy the benefit of following club horses through the subscription period. The objective and intention throughout the year is to maintain at least 2 horses in training and the club's primary function is for enjoyment, it is not an investment opportunity.
2. In addition to the main objective of racing horses, members have the benefit of sharing in the racing club colours, enjoying regular social events and yard visits as noted in the social diary each year together with regular newsletters and access to the progress of the club horses at all times.
3. All decisions relating to the club horses and their racing plans shall be left entirely with the Trainer and Racing Manager.
4. The racing club runs up to December 31 each year. The annual subscription is £595 (single) £750 (joint – living at the same address).
5. The maximum membership of the Club is 75.
6. The horses are trained by Alastair Lidderdale of Lidderdale Racing LLP currently based at Eastbury Cottage Stables, Eastbury, Hungerford. Berkshire RG17 7JJ, with whom Royal Windsor Racing Club has a contract, which defines Terms & Conditions.
7. It is understood by the member that *Kilburn* is solely owned by Lidderdale Racing LLP and leased to the Royal Windsor Racing Club for enjoyment purposes and at no time does the member have a legal or equitable interest in any of the horses leased regardless of ownership. A 49% share of an un-named un-race Royal Windsor Racing Club horse is offered to Royal Windsor Racing Club members who will be entitled to a share of 49% of any winnings and the proceeds of any sale.
8. In the event that any horses are injured such that they cannot be raced and are thus withdrawn from the lease contract Royal Windsor Racing Club will use best endeavours to substitute another so that 2 horses are maintained in training at any one time.
9. An allocation of race day Owners & Trainers badges will be available free to members at a race meeting when a club horse runs. These will be allocated on a first-come first-served basis subject to the proviso that first refusal will be given to a member who has not been able to attend any race meeting during their membership period.
10. Members who wish to place bets on the club horses do so at their own risk. Royal Windsor Racing Club is not a betting club and information provided in relation to the wellbeing of our horses shall be taken as a guide only for the sole use of the members.
11. The Nominated Partners of the Racing Club are:
 - Commercial & Marketing Manager, Royal Windsor Racecourse – Matthew Foxtton-Duffy
 - Racing Manager, Lidderdale Racing LLP – Kevin McCarthy
12. All rights conferred to the member by the club are personal to the member alone and may not under any circumstances whatsoever be gifted, sold, assigned, leased or offered to any other person or party.
13. Ancillary Charges: these may apply when a contribution is required by a member for a social event should they wish to attend and will be offered at commercial rates.
